## **REPORTS**

Councilmember Fairley reported: He mentioned he will be attending the Holiday Social this Saturday.

**Councilmember Thomas** reported: He reviewed a letter from King County to our shops. It talked about the south end treatment plant in Renton and how they will run at capacity. If it comes down to flooding it will contact businesses to shut down.

Councilmember Britz reported: None

**Councilmember Osborn** reported: She attended the Board meeting today and since Joanne Barkley is not at the center, John the bus driver is asking for partnership with the 501C board to take over what he can. They are taking over certain things to keep the programs they have right now. She handed out an intake survey and it shows that 96 people from Algona have been helped by the Community Center. She mentioned that Charlene Whetham is now in a home and Pete is by himself. Karen Rames has been helping with Pete. She wanted to make sure

someone brought him a dinner from the Holiday Social this weekend.

**Councilmember Viney** reported: He attended the Solid Waste meeting last week. They went through the report. If the Legislature adopts the street utility tax we would get a lot of taxes for our streets. It could only be spend on maintenance. Not sure if this will pass. He also talked to them about the screening of the trees that were planted. He told them our City Council wants the trees maintained.

**Mayor David Hill** reported: One concern is we had a peer review done on a wetlands determination report submitted to the City. It was done by 4M Consulting. The location is at 8th and Algona Blvd and they indicated that it was farm land and had no water on it. We should be hearing more once Jones & Stokes reviews the information.

Diana Quinn reported: None

**Buster McGehee** reported: He commented about the Police shooting in Lakewood this last weekend. He mentioned that within 1 hour of the shooting the suspect was here in Algona. Our officers will be assisting Lakewood by covering shifts during the funeral.

**AUDIENCE PARTICIPATION** – James Farmer 657 Main Street - He asked if Algona has any street lighting program. The Mayor responded that we do not have a program at this time. He mentioned his concerns as to the location on Main and would like to see improvement if and when it may become available.
