Councilmember Fairley reported: He mentioned on a personal note that they have hired 2 employees for his business so that he can spend more time participating in Algona.

Councilmember Britz reported: He mentioned sending more car show applications out. He said he talked to National Construction Rental about the toilet rentals for Algona Days. We have a hot dog vendor signed up and Black Bear Diner in Federal Way is donating a \$25.00 gift card and cakes and pies for the cake walk.

Councilmember Osborn reported: She mentioned that the new calendars went out from the Community Center and they included flyers for the garage sale. She is still working on the flood relief where they have helped about 15 people. She said they still have funding and for it, Mayor Hildreth, City of Pacific, has Lynda as the fiscal agent for the chainsaw carving and the Community Center will receive 20% of the proceeds through the auction. The Tea and fashion show is coming up n June 20, 2009.

Councilmember Viney reported: He just reminded everyone of the Farmer's Market starting on June 14th.

Mayor David Hill reported: He mentioned attending the Public Official Training Academy at Valley Communications. He talked about how their process works and how they handle the emergency calls that come through. He said the union has agreed to us hiring an additional Public Works person in a temporary position. He said that Officer Sutter and the Police Department are working with the VFW to see about having them attend Algona Days.

Scott Jones reported: He attended an asphalt grading class where he learned how to calculate and rate a street. The building season has approached us and he has found numerous violations out in the City with people doing work on their homes. He has sent them to City Hall for permits.
